#### 4. First-aid Measures

#### 4.1 Description of First Aid Measures

GENERAL NOTES: Show this safety data sheet to the doctor in attendance.

**AFTER INHALATION:** Move to fresh air. Provide fresh air, rest and warmth. Call a physician immediately. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position. **AFTER SKIN CONTACT:** Use a mild soap if available. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician.
